Gil called the meeting to order at 6:30 p.m. Joel seconded the motion and the vote was affirmative.

Ray Burton/Semi Annual Attendance:

Ray specified that this was a bi-annual visit that he is paying to all the Select Boards in District 1 as County Commissioner. He gave a brief overview on what was happening in the County Government.

Public Participation:

Bob Stahler:

Bob asked the Board to consider putting "no smoking" signs in all of the parks. The Board explained that they do not want the parks full of signage and noted the difficulty of enforcement.

Bob asked the Board to consider the use of his property on Daniel Webster Highway when evaluating a location for a new water storage tank. Jim explained that the Town is in the final phase of the study but noted that Bob's property had already been considered in the evaluation process.

Hazard Mitigation Grant Agreement/Contract Amendment:

NH HSEM has received a one year extension on the 2010 Pre-Disaster Mitigation Grant bringing the completion date from September 9, 2013 to September 10, 2014. Joel motioned to accept the grant amendment. Gil seconded the motion and the vote was affirmative. The grant agreement was signed by the Board and notarized by Judy Welch.

The Board signed a thank you letter to Woodstock Sand & Gravel for donating all the stone for the reconstruction of the wall surrounding Soldier's Park.

NHDES Letter/Cross Connection:

The Board reviewed and signed an informational letter addressed to NHDES. This letter was to update NHDES on the status of our cross connection surveys and backflow testing.

New Business:
