Gil called the meeting to order at 6:30 p.m. Joel seconded the motion and the vote was affirmative.

**Public Participation:**

**Michael Donahue:**

Mike questioned the outcome of the meeting that was held between the school administration and our Director of Public works to discuss the plowing of the school parking lots. Mike also questioned whether the Memorandum of Understanding had been updated and approved by the Town.

Gil explained that the Town has some logistics to work out but will continue to plow as they have in the past. Gil also noted that he has been working with the Superintendent on the Memorandum and she is currently having a new one drawn up for both towns to approve before it goes before the School Board for approval.

**Patrick Griffin:**

Patrick pointed out that funds had been appropriated in 2013 for prosecution. Patrick questioned when the prosecution for the town was going to be turned over to the Plymouth Prosecutors.

The Board was unsure but told Patrick that they would look into it.

**George Spanos:**

George approached the Board about a setback issue that he is having with his neighbor. George explained that a neighbor has built a rock retaining wall on his property and has started putting stones blocking a right-of-way. George asked the Board for guidance and questioned whether it was a town or civil matter. The Board believes the setback issue would be considered a town matter and will contact legal counsel but explained that the right-of-way issue would be considered a civil matter.

**Application/Cascade Park/Maura Connors:**

The Board reviewed an application, from Maura Connors, to use Cascade Park on May 10, 2014 for a wedding ceremony. Joel motioned to approve this application. Jim seconded the motion and the vote was affirmative.

**Hell's Gate Fireworks/Old Home Day:**
