

**Town of Woodstock  
Selectmen's Meeting  
Tuesday, May 27, 2014**

Joel called the meeting to order at 6:30 p.m. Gil seconded the motion and the vote was affirmative.

**Public Participation:**

**Patrick Griffin:**

Patrick submitted a request, under the Freedom of Information Act and State Public Records Laws, for a copy of the public and non-public minutes for the Selectmen's Meeting held on May 13, 2014.

**Mike Donahue:**

Mike pointed out that the current tax maps for the town indicate Potato Hill Road running in front of his house on the easterly side when in fact it runs on the westerly side of his house. Mike requested that the tax maps be changed to accurately reflect the location of Potato Hill Road.

Mike questioned the status of Potato Hill Road.

Mike explained that his son planned to build a house on his property and then subdivide at a later date. He questioned what setbacks he would have to meet when he subdivided. The Board referred Mike to the Planning Board.

Mike inquired about the 250<sup>th</sup> Anniversary Banners. The Board agreed to auction them off sometime after Lincoln's 250<sup>th</sup> Anniversary Celebration.

**Rex Caulder:**

Rex has a signed contract with Toby Abend to replace the waterline and connect the mobile home park to town sewer. Rex questioned the town requirements for the type and size of pipe. The Selectmen will work out the details and send a confirmation letter to Rex by the end of the week. Discussion was also held concerning the permits to connect to town sewer, tap fees, and water meter.

The Board reviewed and signed a letter addressed to the Alpine Village Condominium Association. The letter requests permission to begin the Lincoln-Woodstock July 4<sup>th</sup> Parade at the Alpine Village.

**Application/Cascade Park/Mike Long & Heather Johnson:**

The Board reviewed an application from Mike Long & Heather Johnson to use Cascade Park on August 22, 2015 for a wedding ceremony. Joel motioned to approve this application. Gil seconded the motion and the vote was affirmative.

**Application/Soldier's Park/Doug Moorhead/Rotary:**

The Board reviewed an application from Doug Moorhead, on behalf of the Lincoln-Woodstock Rotary Club, to use Soldier's Park on July 4<sup>th</sup>, 2014 for a barbeque fundraiser to raise money for Linwood Senior Citizens. Gil motioned to approve this application. Jim seconded the motion and the vote was affirmative.
