Tuesday, June 5, 2012

Jim called the meeting to order at 6:30 p.m. Gil seconded the motion and the vote was affirmative.

Public Participation:

Dick Barisano & Bob Stahler/Soldier's Park:

Dick and Bob asked the Board to review two different designs for Soldier's Park. After review and discussion the Board chose the angle design and suggested that Dick should get the material pricing together before the town begins the sidewalk replacement project.

Patrick Griffin:

Patrick followed up on a Non-Public meeting he had with the Select Board on April 10, 2012 concerning an elected official. Patrick questioned whether the situation had been addressed. The Board stated that they had taken this under advisement but noted that they have limited authority over elected officials

Patrick notified the Board of a situation that occurred at the Solid Waste Facility. Patrick stated that he had an altercation with Paul Beaudin concerning the way he disposed of his trash.

Patrick submitted public record requests under the Freedom of Information Act and Public Law. Patrick requested all documents concerning the purchase of the new skid steer and the trade of the old skid steer at the Solid Waste Facility, all fire logs and fire reports from 2003 through 2010, and all police reports or records with his name on it.

Patrick wanted to know what was happening with the damaged guardrail on Lady Slipper Road. Steve stated that he has reported the incident to Chief Moorhead and is waiting for an estimate from the guardrail contractor.

Danny Bourassa:

Danny questioned the status of the sidewalk replacement program. Danny feels the section in front of Alpine Lodge should be looked at. Danny is concerned with the amount of seniors that will be walking that 150 ft section of sidewalk when the elderly housing opens. Jim stated that the town plans to continue with the sidewalk replacement program and funding would be included in next year's budget. The next scheduled section of sidewalk to be replaced is at Soldier's Park which is already in progress.

Minutes of the May 22, 2012 Meetings:

Gil motioned to accept the minutes of the May 22, 2012 Selectmen's Meeting. Joel seconded the motion and the vote was affirmative.

Building Permit/Peter Falso:

The Board reviewed and signed a Building Permit Application submitted by Peter Falso. Map 115 Lot 001-000-MH0-00023

DES/Compliance Report/Race Track:

The Board received a compliance letter from the Department of Environmental Services concerning the operation of the White Mountain Motor Sports Park. Gil motioned to table this letter so that the information provided can be reviewed. Jim seconded the motion and the vote was affirmative.

NRCS/Lost River Stabilization Project/State Representatives:

On May 29, 2012, the Board completed a site visit with NRCS and State Representatives to review the Lost River Stabilization Project. During the site visit engineers from NRCS noticed that big rocks had fallen into the river and there had been some shifting and adjustment to the wall. NRCS will implement a plan to make the necessary repairs.

Trugreen/Tick Control/Cascade Park:

The Board reviewed a Tick Control Application Contract, for Cascade Park, from Trugreen. Gil motioned to sign the contract. Jim seconded the motion and the vote was affirmative.

Old Fire Station/Lost River Road:

John Smith has been hired to make the necessary roof and chimney repairs at the old fire station. Steve will make contact with John MacKay and Paul Beaudin to schedule a clean out day.

Cell Phone Policy:

The Board has tabled the cell phone policy. They will create a draft policy and distribute it to all department heads for input before adopting.

New Business:

Signed Checks.

Steve reported that the motor and fan are gone in the air conditioning unit. The parts are ordered and should be installed next year.
