**Letter/Robert McAfee/Current Emergency Ways:**

The Board discussed a letter submitted from Robert McAfee, on August 29, 2012, requesting copies of agreements and any updates and documents that may apply in support of the requirements established in NH RSA 231:59a. to justify the organizations that the Town deemed "emergency ways".

Following this information request from Robert McAfee the Board consulted legal counsel. Legal Counsel advised the Board that they would have to discontinue plowing White Mountain Attractions, Pemi Valley Church, Lin-Wood Ambulance Service, Dr. Rodney Felgate, and by extension, all senior citizen driveways. Joel motioned to accept the advice from legal counsel with regret and notify all that will be affected in writing. Gil seconded the vote was affirmative.

**Order of Notice/Northern New England Telephone Operations LLC:**

The Town of Woodstock, along with 150 New Hampshire Municipalities, has been served an Order of Notice and a Petition filed by Northern New England Telephone Operations LLC. seeking declaratory judgment and abatement of certain property taxes unconstitutionally and illegally assessed against it by the Town of Woodstock.

The Board has asked Mitchell Municipal Group to file an Appearance and represent the Town of Woodstock in this case.
