Town of Woodstock Selectmen's Meeting Tuesday, April 30, 2013

Gil called the meeting to order at 6:30 p.m. Jim seconded the motion and the vote was affirmative.

## **Public Participation:**

### **Old Fairfield Road/Jim Young:**

Jim recognized a letter he received from the town's attorney. Jim wanted the Board to know that he agrees with everything outlined in the letter. Jim pointed out that the letter references .83 miles when in fact there is only .083 miles. Jim thanked the Board for agreeing to maintain 160feet of Old Fairfield Road and the culvert.

Jim informed the Board that the entrance is washed out and railings need to be installed on the bridge.

Jim asked permission to maintain the Class 6 portion of Old Fairfield Road. The Board agreed to allow general maintenance but pointed out that no changes can be made to the road without the approval of the Director of Public Works.

Chief MacKay presented the Board with a letter, from the officers and members of the Woodstock Fire Department, regarding the idea of combining the Woodstock and Lincoln Fire Departments. The letter clearly states that the Woodstock Fire Department does not support combining fire department and outlines the negative impact it could have on the Town of Woodstock.

### **Review Letter/Interest Reduction/Wendy Springer:**
