Gil called the meeting to order at 6:30 p.m. Jim seconded the motion and the vote was affirmative.

[b]Public Participation:

[b]Terry Whipple/Blasting/Daniel Webster Highway:

Terry expressed his concerns about the blasting that is going to take place on Daniel Webster Highway. Terry stated that the property is adjacent to his property and questioned why he hadn't been notice.

The Board informed Terry that the owner hadn't submitted anything other than a driveway permit, issued by the State of NH DOT, to the Town. The Board noted that it is the blasting company's responsibility to notify the abutters and all emergency response.

[b]Police Department/Sergeant Promotion/Ryan Oleson:

The Board signed an appointment that promoted Ryan Oleson from his current Corporal position to a Sergeant position. The following appointment was read aloud:

To Ryan F. Oleson of Thornton NH, in the County of Grafton.

Whereas, there is a vacancy in the office of Police Sergeant in the Town of Woodstock New Hampshire and whereas we, the subscribers, have confidence in your ability and integrity to perform the duties of said office, we do hereby appoint you the said Ryan F. Oleson of Thornton NH as Police Sergeant of said town, and upon taking the oath of office, having this appointment and certificate of said oath of office recorded by the Town Clerk, you shall have the powers, perform the duties, and be subject to the liabilities of said office, until another person shall be chosen and qualified in your stead.

We understand you want to repair and maintain the Class VI portion of Old Fairfield Road. We ask that before you do any maintenance; make any repairs, or modifications you check with our Director of Public Works first.

Please note: this road is a Class VI Road and the Town "Does Not" maintain this or any Class VI Roads.

[b]Sign/Deputy Town Clerk Appointment/Judith Boyle:

The Board appointed Judith Boyle to the part-time Deputy Town Clerk position. Appointment was signed.
