Public Hearing

Charyl opened the Public Hearing at 5:00 pm.

Charyl explained that pursuant to RSA31:95-b, a noticed Public Hearing was necessary to take public comments on the accepting and expending of unanticipated revenue from the NHDES Drinking Strategic Planning Grant in the amount of \$36,500 to complete a source water evaluation and manganese reduction.

NHEC/Easement/106-101

Charyl stated that NHEC would like an easement to bury a line across the corner of 106-101(town property - municipal sign) to 17 Lost River Road. The current source does not have the means to provide enough power for what they want to do there. The current source comes off the pole on Lost River Road. NHEC would like to run power from Main Street to this property.

Charyl asked for a motion to approve the request.

Scott made the motion, and Gil seconded it. The vote was affirmative.

Old/Other Business/Brought forth by the Board

Scott mentioned that a permit should be coming soon for the old fire station property.

Scott also mentioned that an RFP document to give to the paper would be coming in a few days for the paving of Clark Farm Road, with Ice Castles funding the project.
