Ryan Oleson

**Police Payroll** reflects a wage adjustment for officers, 53 weeks of payroll, and 3% pay raise.

Part-Time Payroll increase due to additional part-time staff to cover shifts and work special details. This will help reduce overtime when staff is out on vacation, sick, or personal time. Ryan noted that we provided 24 hour coverage with 6 officers.

**Prosecution Costs** - Budget down. No longer use Plymouth Area Prosecution. Have an Inter-Municipal Agreement for Regional Municipal Prosecutor with Campton and Lincoln.

All other line items remain the same.

Roberta noted that the Police Department is up for a cruiser this year. The equipment schedule reflects two years on one year off.

Steve question if Ryan has approached the Town of Lincoln about possibly sharing part-time help. Ryan says he has not.

• 4290 - Emergency Management

Ryan Oleson - Budget remains the same.

No questions asked.

4299 - Other Public Safety

**Communication:** Police are currently dispatch out of Grafton. Ryan has been approached by the Town of Lincoln about dispatching through them.

Ryan noted:

4055 calls through Grafton County Dispatch.
100 were Fire Department calls, remaining were Police calls.
Currently costing the Town roughly \$70,000.

Lincoln has offered a two year Inter-Municipal Dispatch Agreement for \$18,000 annually. Ryan recommends the switch.

The Fire Department has not been approached by Lincoln yet; Only Police. Fire would remain with Grafton which is the remaining part of the communication budget.

Charyl asked that Fire be approached prior to presenting their budget.

Ryan explained that we pay Grafton quarterly. We are currently paid through December. Grafton operates on a fiscal budget and the Town runs on a calendar year so he would like to have this approved tonight and make the switch beginning in January.
