Jim called meeting to order at 6:30 p.m.

DOT/Informational/Craig Green & Bob Davis:

DOT gave an overview of the pavement preservation project for Route 112 beginning in the spring 2010. This project will run 4.83 miles, starting west of Beaver Pond parking lot to the intersection of 118. The plan is to reconstruct pavement on road and pull off areas bringing it up to surface, repair catch basins, and replace damage guardrails. Completion date set for August 2010.

The Board stated they had received a letter from White Mountain Attractions expressing their concerns about traffic flow and access points and how this would affect the impact of their businesses. DOT stated that there will be no problem. There will be one-way traffic on pavement and all access points will be left open.

DOT requested the Board sign a Municipal Work Zone Agreement giving the State full control over the work zone.

Casey Gordon/Tim Scott/911:

Tim Scott and Casey Gordon are trying to get all the older/smaller Towns up to quality standards and offered their help to bring us up to date with the rest of the state. The Board reviewed and signed the acceptance letter and data release letter to start the process.
