The Board will meet Thursday, April 18th at 1:00pm to tour the old fire house and put together a scope of work for the RFP. Scott will start working on the Moose Grant and will contact Bill Mellett to gather some history and pictures.

Alba Architects/Woodstock Town Office:

The Board reviewed a Facility Need and Improvement Study Proposal prepared by Alba Architects for the Town Office Building. No action was taken and discussion was tabled. The Board asked Judy to invite Stuart Anderson to the next meeting to answer some questions.

New Vision Plan:

The Board reviewed the new vision plan. Scott motioned to make the plan available to the town employees at their cost. Joel seconded the motion and the vote was affirmative.

Check Request/Woodstock Firefighter Fund:

Gil motioned to approve the check request for \$2,700.00, payable to Industrial Protection Projects, for a thermal imagining camera. This money is to be withdrawn from the Woodstock Firefighter Capital Reserve Fund. Scott seconded the motion and the vote was affirmative.
