Application/Cascade Park/Woehl & Dawson:

The Board reviewed an application from Joshua Woehl and Brittany Dawson to use Cascade Park on September 16, 2020 for a wedding ceremony. The required fee and insurance coverage have been received. Gil motioned to approve the application. Charyl seconded the motion and the vote was affirmative.

Old Business:

Parks:

The Board discussed the many emails and letters of concern and frustration pertaining to the local parks and beaches. Several different alternatives were discussed. The Board would like to try posting a "warning to the guests" sign and increase police presence to see if that makes a difference before shutting the parks completely down.

Fourth of July Celebration:

Discussion was held pertaining to fireworks. Scott will work with the Town of Lincoln to narrow down a date and establish a location.

Summer Concert Series:

The Summer Concert Series will begin on July 25th.
