Town of Woodstock Selectmen's Meeting Tuesday, April 16, 2013

Gil called the meeting to order at 6:30 p.m. Jim seconded the motion and the vote was affirmative.

Public Participation:

Old Fairfield Road:

Bonnie Ham:

Bonnie explained that the Planning Board acted in good faith when approving the subdivision. The Planning Board voted to take this position, per legal counsel, and request that the Select Board rescind their action taken on the road at the February 19, 2013 meeting.

Patrick Griffin:

Patrick expressed his dissatisfaction concerning Old Fairfield Road and the way it was left at the last Planning Board Meeting. Patrick explained that both Boards are setting precedence. Patrick wants the Boards to be consistent and put closure to this.

Select Board:

Gil explained that he was misinformed and when the vote was taken to resume the road, he was under the impression the Town would be maintaining the first 160 feet (Eastside Road to old school house).

Joel motioned to rescind the action taken on February 19, 2013 to maintain Old Fairfield Road for .083, miles reverting back to the way it was in 2006. Jim seconded this motion and the vote was affirmative.

Jim motioned to maintain the Class 5 section of Old Fairfield Road, per letter from the Board of Selectmen dated November 20, 1981 and recorded at Grafton County Registry of Deeds reference Book 1435 Page 553. This section of road runs 160 feet in from Eastside Road to the old school house. Gil seconded this motion and the vote was affirmative.

Minutes of the April 2, 2013 Meeting:

Joel motioned to accept the minutes of the April 16, 2013 Selectmen's Meeting. Jim seconded the motion and the vote was affirmative

Jim motioned to accept the non-public minutes of the April 16, 2013 Selectmen's Meeting, Joel

seconded the motion and the vote was affirmative.

Excavation Tax Warrant/Donahue:

The Board reviewed and signed an Excavation Tax Warrant for Michael and Bobbi Donahue. Map 112 Lot 002-000-000-00000.

Blind Exemption/Eileen Latham:

The Board reviewed and signed an updated Blind Exemption Application for Eileen Latham. Map 115 Lot 001-000-MH0-00010.

Thank You Letter/NH the Beautiful:

The Board signed a thank you letter to NH the Beautiful for awarding the Town of Woodstock an \$1800 grant to help with the purchase of a new vertical baler for the Lincoln-Woodstock Solid Waste Facility.

Proposal/Monitored Security System/Town Hall:

The Board reviewed and discussed a proposal from J.S. Adams Security Systems to supply and install a monitored security system for the Town Hall in lower Woodstock. Jim motioned to accept J.S. Adams Security Systems proposal. Joel seconded the motion and the vote was affirmative.

Road Inventory/Highway Block Grant:

The Board reviewed the Road Inventory Nodel Reference Guide, which is used to determine the Highway Block Grant, at a workshop held earlier today. There were several misrepresented roads listed on the reference guide. The Board has completed the necessary paperwork; need to correct these errors, which will be submitted to the State of New Hampshire Department of Transportation.

Old Business:

Soldier's Park:

Work has begun at Soldier's Park. The Board reviewed signage and the budget.

Furnace:

Jim will contact Oak Ridge Oil & Propane to check on an installation date.

Ice Pigging:

A tentative date for Ice Pigging has been set for May 22, 2013.

Stone Wall/Curbing:

JD Granite will be coming tomorrow to give an estimate on the repair of all the stone walls and the curbing by Alpine Village.

Reservoir Road:

Work will begin on the Reservoir Road as soon as the snow and ice are gone. The culverts and crush have already been delivered.

New Business:

The Board received notification from the NH Department of Transportation about a guardrail replacement project that will begin this summer on Route 112.

The Town will be requesting quotes to pave Parker Ledge Road.
